The Action Plan encompasses the changes in curriculum that reflects the escalation of acuity in the health system and better aligning the scaffolding of competency development across the entire program. Additionally, the need for more simulation rooms is clearly articulated, reflecting the requirement for practice opportunities for our students in light of the more critical clinical placement milieu, and greater competition for clinical placements with an expansion of over 600 nursing seats in the province.
