# a) NURSING

i) Discontinued Program: Post Graduate Certificate in Nursing Leadership and Management

The proposal formally discontinues this program, which has not been offered in many years. The program was the precursor to the Post-Degree Certificate in Nursing Leadership and Management, which is also being discontinued.

### b) NURSING

i) Course Change: HCAS 1220

The course has been moved to Term 1 of the HCAS program as requested by the BC Care Aide and Community Health Worker Registry. Therefore prerequisites are removed and the course is made a corequisite for all Term 1 courses.

#### 6. CURRICULUM

## A) RECREATION STUDIES

### a) Bachelor of Recreation Management - Full Program Proposal

This program change was previously approved in principle by Education Council on December 15, 2020, pending approval by the Degree Quality Assessment Board (DQAB). The BRM was originally approved by the Ministry in 2008, but has undergone subsequent changes which were considered substantial and therefore required reassessment and approval by DQAB before continuing to admit students into the program. Review and consultations were then accomplished through an accelerated timeline, after which the FPP was posted to PSIPS for the required period, and then forwarded to DQAB, which requested a desk audit after which approval was received from DQAB on September 14, 2021. The changes do not involve new courses, and the program's budget is unchanged. The BRM will continue under the 2+2 model, with students entering at the third year level following completion of a Recreation diploma or other post-secondary credits. As a result of the program review, learning outcomes and program objectives have been updated, and MARK 2100 has been replaced in the curriculum by MARK 3110.

IT WAS MOVED by J Bowers, seconded by R Macqueen, that Education Council approve the Full Program Proposal for the Bachelor of Recreation Management for implementation.

### b) Program Changes

i) Bachelor of Recreation Management

As previously approved in principle, changes include the updating of admission requirements, and the replacement of MARK 2100 with MARK 3110 in the curriculum. The implementation date has also since been updated, and admission is expected to resume for the September 2022 semester.

J Bowers agreed to forward by email his confirmation of previous consultations with the Marketing Management department.

### a) Program Change

i) Certificate in Health Care Assistant

Proposed changes will facilitate student admission and progression in the program, and include: decreasing the English Studies, Literary Studies, and English First People's admission requirement percentage from 67% to 65%; moving HCAS 1220 from Term 2 to Term 1, as required by the BC Care Aide & Community Health Worker Registry; and removing the N95 Fit Test requirement.

Because HCAS 1220 is being moved from Term 2 to Term 1 of the Health Care Assistant program, it is changed from a corequisite to a prerequisite for Term 2 courses, and added as a corequisite for Term 1 courses.

Registrar and Enrolment Services is currently working on a revised Admissions policy with a committee appointed by the Deans, Directors, and Division Chairs Committee.

### A) ENGLISH: LET Replacement - Spring and Summer 2022

The English department is extending until May 31, 2022 the plan previously put into place to provide alternatives for the Langara English Test (LET), which was suspended due to COVID-19. Although the LET has since been relaunched, it is running at a limited capacity. As well, there are still many students who are studying from outside of Canada and cannot attend to take the test in person. Therefore the alternatives will remain in place to ensure all students can be accommodated.
