1. CALL TO ORDER

The meeting was called to order at 1305 hours upon declaration of a quorum.

2. APPROVAL OF AGENDA

3. APPROVAL OF THE PREVIOUS MINUTES

MOTION:

That the minutes of the Education Council meeting held April 15, 2008 be approved as circulated.

4. CURRICULUM

- A) ECONOMICS
- a) New Course Proposal
- i) ECON 2260 Environmental Economics
- ii) ECON 2280 Labour Economics

Both new courses are intended to broaden second year offerings by increasing choices for students with topics of current public interest, and are transferable to SFU and UBC. A number of other departments have been consulted, with the expectation that these courses will have broad appeal. The proposed date for offering the courses is Fall 2009.

The proposed revisions affect LET exemption (80% of final grade in BC English 12 or BC Literature 12), LET/LPI equivalents, and prerequisite statements for affected English courses. Changes will encourage students to take the LET instead of the LPI. The LET is better than other tests at placing students accurately in the appropriate level of English. Students may earn credit for only one of ENGL 1126, ENGL 1127 or ENGL 1128.

MOTION:

That the revisions to LET/LPI equivalencies and related prerequisite changes described in the agenda package be approved by Education Council.

Discussion followed. It was noted that the proposed revisions have the widespread support of the English department. A transition plan needs to address students admitted to career programs under now outdated admission requirements.

N. Currie departed 1325.

R. Semmens moved to amend the motion as indicated (amendment italicized). The motion to amend the motion was approved by consensus.

MOTION:

That the revisions to LET/LPI equivalencies and related prerequisite changes described in the agenda package be approved by Education Council, with the effective date being 200830 for courses listed above and 200910 for changes to LET/LPI equivalents for admission to specific career programs in Fall 2009.

Both proposed new courses address topical issues. PHIL 1120 will be relevant to students taking environmental studies courses and to students interested in developing their knowledge of philosophy in general. PHIL1140 will examine the controversial philosophical issues around religious belief. Both courses are to be offered Fall 2008.

That the new courses *PHIL 1120 – Environmental Ethics* and *PHIL 1140 – Philosophy of Religion* be approved by Education Council.
