#### 5. **CURRICULUM**

#### A) APPLIED URBAN & RURAL PLANNING

- a. Course Change
- APPL 2350 Applied Planning Practicum
- I. McBain presented on behalf of G. Wren.

APPL 2350 was designed and taught as a letter-graded course, however due to a data entry error, the course was coded for S/U evaluation. Council was informed of this error at the March 15, 2011 meeting. A retroactive correction is needed in order to grade students who have now completed the course.

### **B) HEALTH SCIENCES**

- a. Course Change
- HSCI 2214 Perspectives on Mental Health and Illness

The proposed change will add "...or with permission of the instructor" to the prerequisite statement, which will open the course to students who are interested in the subject but do not plan to pursue Health Sciences as a career.

HSCI 2216 - Ecological Determinants of Human Growth, Development and Health

Removing HSCI 1130 as a prerequisite will bring HSCI 2216 in line with the requirements of its equivalent at SFU (HSCI 216), with the remaining prerequisites being "One of BIOL 1115, 1116, 1175, 1190 or HKIN 1190".

The Department of Design recommends that graded final projects replace written final exams in all studio courses. Written midterm tests would still be used to acknowledge critical concepts of lectures. The change would affect all studios effective Fall 2011, specifically DSGN 1151,1152,1153,1154,1250,1252,1253,1255, 2100, 2151, 2152, 2153, 2154, 2251, 2252, 2253,2254

A second proposed change will add AHIS 1301 and 1302 as electives in the Design Formation program
