### Section 1: Purpose

- (1.1) In accordance with the *College and Institute Act* (the “Act”), the Board must make by-laws establishing the fees and charges to be paid to the College by students.
- (1.2) The Act also requires the Board to direct the College to collect and remit student society fees on behalf of the student societies of the College.

### Section 2: Definitions

- (2.1) In this By-Law:
  - “**Board**” means the Langara College Board of Governors.
  - “**College**” means Langara College.
  - “**Mandatory Fees**” means charges other than Tuition Fees that a student is required to pay to be registered as a student at the College or in a particular course, degree program, diploma program, certificate program, post-degree certificate program or post-degree diploma program. Mandatory Fees include but are not limited to the following: materials/lab fees, prior learning assessment fees, Capital Building Legacy Fund, International Education Development Fund, and U-Pass BC Program.
  - “**Langara Students’ Union**” or “**LSU**” means the society registered under the British Columbia *Society Act* as “Langara Students’ Union Association” comprised of all registered students of the College.
  - “**LSU Fees**” means the fees approved by a majority of the members of the LSU who voted in a referendum of the LSU.
  - “**Tuition Fees**” means charges for instruction that a student is required to pay to register in a particular credit course offered by the College.

### Section 3: Guiding Principles

- (3.1) Tuition Fee and Mandatory Fee increases shall comply with current provincial guidelines.
- (3.2) Ensure that programs and courses are affordable and accessible.
- (3.3) Tuition and Mandatory Fees for new programs will be set by the Board and thereafter comply with current provincial guidelines.
- (3.4) Programs that are substantially changed, and in keeping with provincial guidelines, may be submitted to the Ministry for review.
- (3.5) New mandatory fees may be introduced for new services, if there is a clear benefit for students after consultation with students.



**Section 4: Tuition Fees**

- (4.1) Tuition Fees for domestic and international students shall be established by the Board annually by resolution, on recommendation of the Audit and Finance Committee.
- (4.2) Tuition Fees for non-credit (audit) registrations in credit courses shall be the same as for credit registrations.
- (4.3) The annual Board resolutions shall attach a fee schedule consistent with Appendix A.

**Section 5: Mandatory Fees**

- (5.1) The following Mandatory Fees shall be established as follows:
  - (a) Materials fees and laboratory fees vary by course, are established by the Faculty in which the course is offered, and are approved by the Board.
  - (b) The Capital Building Legacy Fund supports capital projects designed to directly enhance the quality of the learning experience for Langara College students and was established by the Board in 2002.
  - (c) The International Education Development Fund is designed to provide direct support to International Initiatives that are aligned with the College's strategic priorities and was established in 2015.
  - (d) The U-Pass BC Program is a mandatory student public transit program. This Mandatory Fee shall be established by the students through an approval process with the Langara Students' Union.

**Section 6: Continuing Studies Fees**

- (6.1) Fees and charges for non-credit courses and programs offered through Continuing Studies shall be established by the Continuing Studies Department.

**Section 7: Other Fees Payable by Students**

- (7.1) Fees and charges for institutional services normally provided by post-secondary institutions (e.g. application fees, transcript fees, late payment fees) shall be established by the Vice-President, Administration and Finance in consultation with the Office of the Registrar.
- (7.2) User fees for services offered by the College to all members of the public (including students) are outside the scope of this By-Law.

**Section 8: Langara Students' Union Fees**

- (8.1) Provided that the LSU is in compliance with the requirements under the Act, on annual notice from the LSU, the College shall collect student society fees and remit them to the LSU.

**Section 9: Senior Citizen Tuition Fee Exemption**

- (9.1) Exemption from payment of Tuition Fees shall be available to British Columbia residents who are 65 years of age or older. Mandatory Fees are not eligible for exemption and must be paid by all registered students.



- (9.2) Senior citizen fee exemptions are only available to courses in which there are seats available after registration has been completed. Senior citizens who wish to ensure registration in a specific course may do so by registering and paying tuition fees in the same manner as other students.
- (9.3) Senior citizen fee exemptions are only available for credit courses.
